ABOUT THE ACCELERATOR

The Circular Economy ClimAccelerator will be a result-oriented programme for startups and enterprises (beyond pilot stage) that address the root cause of waste generation while prioritizing the wellbeing of informal workers and underserved communities in Bengaluru.

The aim is to help startups and enterprises develop leadership and skills to scale their circular business model. A circular business model is an approach to business that aims to eliminate, prevent, and minimize waste and make the most of resources by following the principles of a circular economy.

Through the 6-month tailored programme, participants will receive:

- Equity-free Funding: Up to USD 98,000 available for the top five solutions
- Access to Experts: Guidance on sustainable business practices and circular economy principles by subject-matter experts
- Individual Mentorship: Personalized support from industry professionals
- Impact and Circular Economy Deep Dives: Immersive workshops on impact measurement and circularity

Eligibility – Applications must satisfy all four eligibility criteria shown below to be considered for further assessment.
